Approval of Actions Taken

Unless otherwise indicated, the Committee decisions noted in these Minutes were approved by all members present at the meeting. If a member who was present at the meeting voted against a particular decision, abstained from voting, or was not present when the decision was made, that fact will be noted below.

New Business

The Committee considered Memorandum 2022-04 and its first supplement, which discuss competency to stand trial. The Committee received a special presentation from the Medical Director of the Department of State Hospitals, Dr. Katherine Warburton.

The Committee also heard from panelists on the following topics:

- Approaches to Competency to Stand Trial and Related Matters From Other States and Systems (Judge Leifman, Judge Anderson, Theresa Pasquini, Professor Murrie, and Professor Gowensmith)
- Perspectives on Competency to Stand Trial and Related Matters from California Practitioners (Judge Bianco, Stephanie Regular, Kim Pederson, and Matthew Greco)

The Committee is grateful for the participation of all of the panelists.

The Committee also heard public comment.

The Committee discussed the data presented by Dr. Warburton and the ideas presented by the panelists. After discussion, the Committed directed staff to research the following topics:

- *Eliminating restoration for more cases*: Expanding the scope of SB 317, which eliminated competency restoration for misdemeanors, to certain classes of felonies, particularly those offenses that contribute to a majority of competency restoration admissions at the Department of State Hospitals (i.e. theft, assault, and robbery).
- Allow judges to declare certain individuals unrestorable at the outset: Creating a mechanism for judges to determine in rare cases that a person cannot be restored without the process of committing them to a state hospital.
- *Statutory timeframes*: Creating a statutory timeline that would mandate the return of competency evaluations in a shorter timeframe and creating a fasttrack for people found incompetent to stand trial that are most in need of treatment.
- *Landscape of court ordered mental health treatment*: Mapping the various ways a person may be judicially ordered into mental health treatment e.g. competency to stand trial, conservatorship, assisted outpatient treatment, etc.
- *High-utilizers of competency restoration*: Requiring or encouraging counties to identify the high-utilizers of county and other services that may be related to involvement in the criminal legal system.

Ongoing Business

Following a presentation by the Legal Director, the Committee discussed research updates and proposals from the February 2022 meeting on victims' rights and services. After discussion, the Committee directed staff to continue developing the following three proposals as outlined in Memorandum 2022-06:

- Create a system for state-funded restitution payments to victims;
- Create a victims' right to restorative justice; and
- Modernize civil compromise.
