Approval of Actions Taken

Unless otherwise indicated, the Committee decisions noted in these Minutes were approved by all members present at the meeting. If a member who was present at the meeting voted against a particular decision, abstained from voting, or was not present when the decision was made, that fact will be noted below.

New Business

The Committee considered Memorandum 2023-04 and its first supplement, which discuss selected issues at the intersection of poverty and criminal law. The Committee received presentations about LEAD from Aili Malm, about public benefits from Andrea Brayboy and Kimberly Brauer, and about fines, fees, and other monetary sanctions from Anita Lee, Francine Byrne, and Tarra Simmons.

The Committee also heard from panelists on the following topics:

- Law Enforcement Assisted Diversion (Erica Shehane, Capt. Geoffrey Deedrick, Brendan Cox, Doug Haubert)
- Welfare Fraud (Jeff Chorney, Kamaria Henry, Antionette Dozier, John Martire)
- Fines, Fees, and Other Monetary Sanctions (Lisa Foster, Bryan Sykes, Leon Dixson)

The Committee is grateful for the participation of all of the panelists.

The Committee also heard public comment.

The Committee discussed LEAD, welfare fraud prosecutions, California's system of fines and fees, and the ideas presented by the panelists. After discussion, the Committee directed staff to research the following topics:

- *Limit welfare fraud prosecutions*: Establish guidelines for welfare fraud prosecutions that require more substantial evidence of intent to defraud.
- *Reduce the scope of monetary sanctions*: End or reduce the imposition of monetary sanctions for indigent people convicted of misdemeanors or felonies.
- *Expand LEAD*: Establish additional LEAD pilots and create guidance in the Penal Code encouraging law enforcement to divert people arrested for minor offenses.

Ongoing Business

The Committee considered Memorandum 2023-06, which presented updates on research from the March 2023 meeting. The Committee directed staff to continue developing the following proposals as outlined in Memorandum 2023-06:

- Create general resentencing procedures.
- Apply the "nickel prior" reform retroactively.
- Clarify that SB 81's updates to Penal Code § 1385 apply to strikes.
- Expand second-look sentencing.
- Improve data access to support Racial Justice Act claims.

Administrative Matters

The Committee considered Memorandum 2023-03, which presented an update on 2023 crime statistics.

The Committee considered Memorandum 2023-05 presenting draft Minutes for the Committee's March 2023 meeting.

The Committee approved the Minutes without change.
