## Staff Memorandum 2024-03 Violent Crime Data for 2023

This memorandum is to update Committee members on recent data about violent crime in California.<sup>1</sup>

Data compiled by the Major Cities Chiefs Association, an international association of police executives, show that violent crime declined across many parts of California in 2023 compared to 2022. The data does not include information on property crimes.

The data, which consists of violent offenses reported to law enforcement, cover seven of the most populous California cities, as well as jurisdictions patrolled by the Los Angeles Sheriff's Department.<sup>2</sup> For this group of cities in California, overall violent crime was down less than 1% (specifically, 0.56%) in 2023 compared to 2022.

While violent crime declined in cities outside California by a larger percentage (3.14% compared to 0.56%% in California), California saw a greater percentage drop in reported rapes than cities outside of California — 11.08% in California compared to 7.77% to cities outside California.

Los Angeles County has three law enforcement agencies in the data, the Los Angeles Police Department, the Los Angeles Sheriff's Department, and the Long Beach Police Department. Taken as a group, overall violent crime declined by less than 1% (specifically, 0.85%) in the Los Angeles County jurisdictions. Every category of violent crime except aggravated assault saw a decline, with murders dropping 8%, reported robberies dropping 1%, and reported rapes dropping 6%. Reported aggravated assaults were essentially flat, with 2 more aggravated assaults in 2023 than in 2022.

Oakland saw the largest increase in reported violent crimes of the cities surveyed, with an overall 21% increase in violent crime, including a 38% increase in robberies and a 10% increase in aggravated assaults. With Oakland excluded from the data, violent crime dropped 2.52%.

These crime reports are preliminary and may differ from the final numbers reported by each jurisdiction.

In addition on March 18, 2024, the FBI released preliminary 2023 crime data from more than 40 large cities in California and staff plans to provide analysis of this data soon.
