Dear Sir:

This will acknowledge receipt of your letter of November 19, 1962.
Please be advised as follows:

With reference to appropriation claims, the term "Dismissed" usually means that the claim has been settled with the Department of Public Works after same was filed in this office. It is very rare that an appropriation claim is dismissed. When this type of claim is dismissed, it is usually a case where a man has filed a claim alleging that the State has taken his property although he has not been served with appropriation maps, and it later develops that the man's property was not taken. On occasion, when a case is announced in Court as having been settled, the Judge may announce that the claim having been settled same is dismissed. What he actually means is that the claim has been discontinued. Therefore, the term dismissed and discontinued, in appropriation claims, in almost every case means that the claim has been settled with the Department of Public Works.

With reference to contract claims, the term "Discontinued" means that the case has been settled with the Department of Public Works after the claim was filed in this Court. The term "dismissed" means that the claim was tried by the Court and dismissed.

In tort claims, the term "dismissed" in almost every case means that the case was tried and dismissed by the Court. There may be an occasional case where the case has been settled, and as stated above in appropriation cases, the Court may state that the case be discontinued on the calendar. The term "discontinued" in tort claims usually means that the case has been settled with the State. The only tort cases that the State does settle are cases involving State vehicles which are insured. The term "untried" means that the claim is still pending before the Court as an active claim.

In addition to the above, tort claims may also be settled, not to exceed \$2,500, in accordance with Section 8, sub-division 12 to 13, New York State Finance Law.

I trust this is the information you desire.
