STUDY NO. 34(L) - EVIDENCE CODE

The Commission considered Memorandum 65-10 and ~~the~~ supplements thereto in connection with its consideration of Senate Bill No. 110 (as amended February 24, 1965) and Assembly Bill No. 333 (as amended March 2, 1965).

The Commission approved making all of the amendments to these bills as reflected in both bills as amended March 23, 1965.

In light of this action, the District Attorneys' Association agreed to support the bill in its present form, withdrawing all previous objections and reserving only an objection to subdivision (c) of Section 788, as to which the association would prefer to retain intact the existing law.

STUDY NO. 52 (L) - SOVEREIGN IMMUNITY

The Commission considered Memorandum 65-12 and the First Supplement thereto. The Commission approved the revisions made in Sections 911.6, 945.6, 946.6, and 950.2. In addition, the Commission approved the suggestion to delete from Section 930.4 the reference to Section 946.6 and to add a new subdivision to Section 946.4 to except certain agreement procedures from Section 946.4. Commissioner Selvin abstained from a consideration of this change to the claims statute. The Commission also approved a minor change in language in several sections relating to the Roster procedure.

The Commission approved printing the revised Comments in its recommendation on this subject.
