Memorandum 71-4

Subject: Schedule for Future Meetings

Attached (gold) is the schedule for future meetings. The staff suggests the following revisions:

February meeting (Los Angeles)

Add February 18 - 7:00 p.m. - 10:00 p.m.

Reason: We will need to devote this additional time to garnishment and attachment; also the staff plans to present a relocation expense recommendation for submission to the 1971 Legislature for consideration at the February meeting. (The federal legislation on relocation assistance has passed.)

March meeting (San Francisco)

Delete March 11 - 7:00 p.m. - 10:00 p.m.

Reason: We will need to meet 3 days in February. We should avoid two three-day meetings in a row if possible.

Professor Riesenfeld advises that he will be unable to attend the June meeting (now scheduled for June 10-12 in Los Angeles). We do not know now whether we will be scheduling attachment, garnishment, and exemptions from execution for consideration at the June meeting. Hence, the Commission may wish to retain the present schedule. It would create difficulties to put the meeting over one week (leaving only three weeks until the July meeting) or to advance the meeting one week (leaving only three weeks from the May meeting).
