Subject: Recognition of Distinguished Service by Consultants

We expect to have available at the January meeting a proof copy of the Commission's distinguished service award for consultants. We believe that we will have an attractive award to present to our consultants.

We have listed on the attached sheet all the consultants who have worked with the Commission during the last five years or so and propose that each of them be given a distinguished service award. We further propose that each future consultant be given the same award when he has substantially completed his or her work with the Commission on a particular project.

We have listed only those consultants we listed in our reports to the Legislature as consultants. We also listed Ronald P. Denitz in our report on landlord-tenant relations and strongly recommend that he likewise be given an award. We also strongly recommend that Carl M. Olsen, now County Clerk of San Francisco, be given an award. Both have served as consultants although not formally appointed or designated as such.

The Commission may wish to give an award to additional persons who gave us substantial assistance in our eminent domain study. Roger M. Sullivan and Richard L. Huxtable were of great assistance to us at the legislative hearings and during the development of the legislation. We recommend they be given the award. The following representatives of public agencies attended numerous meetings of the Commission and were of substantial assistance: S. Robert Ambrose, County of Los Angeles; Robert F.
