Memorandum 82-7

Subject: 1982 Legislative Program

Attached is a report on the status of the 1982 legislative program.

Assembly Bill 707 (providing a comprehensive enforcement of judgments statute) was heard by the Senate Judiciary Committee. The Committee indicated that it was unwilling to approve the bill as drafted because it changes the existing rule that a judgment debtor is not entitled to a homestead exemption when the property subject to a judgment lien is voluntarily sold.

Under AB 707, a creditor may obtain a judgment lien on a dwelling by recording an abstract of judgment in the county where the dwelling is located. Existing law permits a judgment debtor to protect himself or herself from this possibility by recording a homestead declaration before the creditor records the abstract of judgment to create a judgment lien. We had proposed to eliminate the provisions for declaration of a homestead in our recommended legislation. However, representatives of judgment debtors are strongly of the view that the restoration of some type of homestead declaration is necessary in the view of the proposed elimination of the provisions of the bill that protect the homestead exemption in the case of a voluntary sale.

Also, the Commission had streamlined the procedure for the sale of a homestead. The representatives of judgment debtors did not object to the Commission revisions, because they appreciated the benefit of the protection of the homestead exemption in the case of a voluntary sale. However, with the elimination of that protection, the staff is attempting to add the substance of various provisions of existing law that protect the owner of a home from sale on execution.
