some particulars on
VITAL STATISTICS, INC.

(Prepared for the California Law Revision Commission)

Vital Statistics, Inc. (V.S.I.) is a California Corporation maintaining its home offices in Glendale, California. The concept and plan of business, the business contacts, and the data processing procedures were analyzed and created over a long period of time. The business was incorporated on August 26, 1983. V.S.I. is a service business devoted to, (1) providing rapid and comprehensive death notices to subscribers, and, (2) providing an economical registration of wills program available to non-subscribers as well as subscribers. The first program is carried on under the service name of "Probate AlertTM"; the second program is currently designated "V.S.I. Will Registrations."

PROBATE ALERTTM involves a monthly monitoring and extracting of death information from high density computer tapes provided to V.S.I. by the Department of Health Services in California. Similar arrangements are being negotiated with the state of Arizona. V.S.I. intends to extend its services into all western states.

V.S.I.'s data processing personnel have taken appropriate steps to read the high density computer tapes produced by the data processing branch of the Department of Health Services. V.S.I. has also developed and uses sophisticated software allowing the prompt input, search, and output of death information. Names of decedents are searched under full names, initials, nicknames and other names used, and social security numbers. Other verification processes include comparing mother's maiden name, and dates and places of birth.

Death notice information is extracted by computers and forwarded by computerized printout (together with a death certificate) to individual attorneys, trust companies, and others who have subscribed and who have provided V.S.I. with a confidential list of testators (candidates) whose deaths they want constantly searched. At the present time V.S.I. accepts a minimum listing of 100 candidates per subscriber at a cost per listing of \$3.25 each. The cost diminishes in scheduled decreasing steps as increased numbers of candidates are listed by a subscriber. The subscriber may add, modify, or make deletions to his list

of candidates at any time. An annual service charge of nine cents per candidate is also made. However, we anticipate this charge will be deleted inasmuch as a representative of the Department of Health Services has advised us that charges to us from the Department will be substantially reduced. A \$45.00 fee is imposed when V.S.I. provides a subscriber with a verification of a death of a listed candidate. Subscribers having knowledge of a death have reasonable opportunity to delete that candidate before any fee is imposed. The \$45.00 fee includes a copy of the certificate of death of the candidate.

WILL REGISTRATIONS. This phase of V.S.I.'s service is a by-product of V.S.I.'s Probate AlertTM. It has recently been offered by V.S.I. to provide a service comparable to the will registration program proposed by the California Law Revision Commission. V.S.I.'s program is designed to primarily service individual will registrants. Any person may register prescribed will information with V.S.I. The registration charge is \$3.50. Probate AlertTM subscribers are automatically included in the will registration program without charge. The registration may be modified or deleted by the registrant at any time, also at a charge of \$3.50. If not deleted, the registration will remain in effect for a period of ten years from the date of registration or last modification (i.e., the latter in time). As in the Probate AlertTM program, information received on a candidate remains confidential until his or her death is verified. A V.S.I. certified copy of the current will registration on verified decedents is available to any person requesting the certificate. In like manner, a certificate will be promptly issued by V.S.I. verifying that no will of such decedent is registered with V.S.I., if such be the case. The certification charges are also in the sum of \$3.50 each. This is a profitable service offered by V.S.I. which is comparable to the service being proposed by the California Law Revision Commission.

GENERAL INSTRUCTIONS

1. **LISTING OF CANDIDATES:** A "Candidate" is a testator who is listed with VITAL STATISTICS, INC. (V.S.I.) for the purpose of monitoring his or her death through V.S.I. computer searches. Candidates can be listed by one of several procedures:

A. **CANDIDATE LISTING SHEETS.** Candidate Listing Sheets are printed in blue and are packaged in tablets. The person who actually fills in the Candidate Sheets should read and be familiar with the printed instructions for completing the Sheets.

B. **CANDIDATE CARDS.** These are a supplemental means of obtaining Candidate information which may be submitted to V.S.I. for listings of Candidates. (A more detailed discussion of Candidate Cards will be found under Item 5 of these Instructions).

C. **COMPUTER RECORDS.** Some larger firms and trust companies have already computerized statistical information on their Will clients. It will be possible in some cases for V.S.I. to extract this computerized data directly into V.S.I. computer records.

2. **SUBSCRIPTION COSTS:** Refer to the PRICE LIST (pink) included among the subscription materials. Initial subscription costs are determined by how many Candidates are initially listed with V.S.I. If you have only a few alias entries (See INSTRUCTIONS for CANDIDATE LISTING SHEETS) you may ignore them in your count. The first 100 Candidates are included with the Subscriber's Basic Subscription Cost (\$325.00) which is paid only once. Thereafter, the balance is computed. **EXAMPLES:** If the Subscriber is initially listing 428 Candidates, the cost will be $[\$325 + (\$.95 \times 328) =]$ \$636.60; if the Subscriber is listing 1008 Candidates, the initial subscription cost will be $[\$325 + (.75 \times 908) =]$ \$1006.00 (It is actually less expensive to list 1001 Candidates than 812 under V.S.I.'s pricing structure.) The Subscriber's check should be drawn in accordance with such computations and be made payable to "VITAL STATISTICS, INC.". A Subscriber's check is mailed in advance only in connection with the subscription process. Thereafter the Subscriber will be billed by V.S.I. as charges are incurred.

3. **THE SUBSCRIPTION DOCUMENT.** The Subscriber should read and supply the information requested in this Document. It constitutes the agreement between the Subscriber and V.S.I. **PLEASE DATE AND SIGN IT.**

4. **SUBSCRIBER'S I.D.:** This provision is incorporated to provide confidentiality to the Subscriber. It is referred to on the CANDIDATE LISTING SHEETS, on the CANDIDATE LISTING SHEET INSTRUCTIONS, and on the SUBSCRIPTION DOCUMENT. The I.D. should also be placed on the CANDIDATE CARDS in the CMPTR.I.D. space. Basically, the SUBSCRIBER'S I.D. is a 6 to 10 character "title" that the Subscriber selects for the personal identification of Subscriber. It may consist of letters, or numbers, or any combination thereof.

5. **CANDIDATE CARDS:** The use of Candidate Cards is wholly optional. It is a supplemental means of obtaining and submitting Candidate information to V.S.I. The first use of the Card is as a questionnaire postcard, mailed with a transmittal letter, to various testators. When returned, the completed Card serves a second use: an index card in the Subscriber's 3 X 5 Will card file. Trimming is necessary because U.S. Postal standards proscribe a 3-1/2 X 5-1/2 minimum card size for mailing purposes. **Before filing, the trimmed Cards should first be mailed with other subscription materials to V.S.I., carefully packaged.** V.S.I. will photocopy the Cards and promptly return them. (Cards are not forwarded to data processing to protect identities.)

Candidate Cards are prepared and mailed by the Subscriber to the Subscriber's testators. Large quantities of cards may be obtained quite inexpensively at local "quick print" facilities. A questionnaire form for the Card is suggested below. (The Subscriber should feel free to cut-out [perhaps photocopy and then cut-out from the photocopy] and paste the form (below) onto one side of a 3-1/2 X 5-1/2 blank postcard.) The Subscriber then pastes the Subscriber's name and address (cut from a letterhead, etc.) on the other side, thereby creating camera-ready copy for the printer of the postcards. **BE CERTAIN THAT YOUR SUBSCRIBER'S I.D. CODE IS TYPED ONTO THE CANDIDATE CARD BEFORE IT IS TAKEN TO THE PRINTER.** This is essential information for data processing. Adding the I.D. CODE after the Cards are printed can be very tedious. Before mailing the printed postcard to a Candidate the Subscriber should also consider typing the Candidate's name and typing the date of the Candidate's last will on the card, if it be convenient to do so.

A suggested form for the transmittal letter is also set forth below:

This is a form letter to our clients for which we apologize. A personal letter would be too difficult an undertaking in the time available. We are enclosing an information postcard which we need to keep our Will records current. Please complete it at your earliest convenience.

There is an important additional reason for obtaining these personal statistics. The computer age has made it possible to rather quickly advise the custodians of wills of the deaths of persons who have made wills. This protection has become especially important in recent years, as persons seem to more frequently become separated from family, friends, and valuable documents. We intend to list all of the Wills in this office with this special service.

The postcard has been stamped and self-addressed to facilitate your prompt response. (If you prefer to enclose the card in a separate envelope, please do so). Thank you for your cooperation.

"Aliases" should be prepared on separate Candidate Cards and be stapled together. Keep in mind that Candidate Cards are only supplements to the Candidate Listing Sheets. A response by more than one-third of the testators polled *will be quite unusual*. The remaining testators should be listed on the Candidate Listing Sheets even if you know no more about them (without special investigation) than their names. (Those testators are the ones whose deaths a Subscriber is least likely to learn of...without V.S.I.!)

6. SUBSCRIBING:

- A. IF 100 OR MORE CANDIDATES ARE READY TO BE LISTED, THE SUBSCRIBER SHOULD NOT DELAY FORWARDING THE SUBSCRIPTION WHILE AWAITING OTHER CANDIDATE RESPONSES. LATECOMERS CAN BE ADDED WITHOUT A MATERIAL DIFFERENCE IN COSTS!
- B. THE FOLLOWING IS TO BE SUBMITTED TO V.S.I. IN CONNECTION WITH THE INITIAL SUBSCRIPTION:
 - (1) THE SUBSCRIPTION DOCUMENT, Signed and Dated.
 - (2) CANDIDATE LISTING SHEETS and/or CANDIDATE CARDS
 - (3) SUBSCRIBERS CHECK, computed as described in provision 2.

7. ADDITIONS OF CANDIDATES: Individual or groups of Candidates may be added at any time. Information on new Candidates may be provided on Candidate Listing Sheets or on Candidate Cards, or on both. If the Candidate Listing Sheets are used, the word "ADDITIONS(S)" should be typed just above the Subscriber I.D. Box. If the Candidate Cards are used they should be carefully packaged for mailing and the word "ADDITIONS(S)" should be conspicuously set forth on the package. V.S.I. will promptly return any Cards received and will provide confirmation of the new Candidates as soon as the computer additions are completed.

8. CHANGES REGARDING A CANDIDATE. Changes of a Candidate's data may be made at any time. Changes should be typed on a Candidate Listing Sheet and mailed to V.S.I. The original information on the Candidate should be set forth *except* as changed. The "CHANGE" Box in the lower right hand corner of the listing frame should be checked to assist processing.

9. DELETION OF A CANDIDATE. A Candidate may be deleted at any time by written notice to V.S.I. This can be most easily effected by postcard notice directing the deletion of a named Candidate (with other identifying information such as Candidate's social security number, *if confusion is likely in connection with the particular Candidate*). The SUBSCRIBER I.D. should also be typed on the card. V.S.I. supplies postcards for this purpose. If the Subscriber knows of the death of a Candidate the Subscriber should delete that Candidate within 45 days of the death. Otherwise the Subscriber may be charged for a "MATCH".

10. CANCELLATION OF ACCOUNT: A Subscriber may cancel the Subscriber's entire account at any time without advance notice and without charge. The Subscriber may reinstate the entire account at any time within a 12-month period thereafter for a flat charge of \$150.00 (under current V.S.I. published prices).

11. CHANGES REGARDING SUBSCRIBER: V.S.I. should be notified by letter of changes in a Subscriber's name, address, etc. The SUBSCRIBER'S I.D. CODE should be set forth in the letter. V.S.I. will provide confirmation of the change as soon as the computer records have been corrected.

8. THE AGREEMENT:

The SUBSCRIBER, named above, herewith subscribes to V.S.I.'s ("Vital Statistics, Inc.'s") California Death Notice Service. SUBSCRIBER agrees to pay for said services pursuant to V.S.I.'s quoted prices, currently in effect (except as hereinafter provided), and to comply with the terms of this document in all other respects. Current V.S.I. prices are set forth on a separate price list, and shall be subject to changes as hereinafter provided. SUBSCRIBER shall be notified in writing of any change in pricing at least 60 days prior to the effective date of such changes. (No changes in pricing made by V.S.I. within a six month period following the effective date of this agreement shall be binding upon SUBSCRIBER.)

SUBSCRIBER may cancel this agreement by a written notice delivered to V.S.I. at any time, without charge to SUBSCRIBER. V.S.I. shall be authorized to discontinue services to SUBSCRIBER in the event of SUBSCRIBER'S default, and commencing one year following the effective date of this agreement, V.S.I. may cancel this agreement, without cause, upon giving a 30-day written notice to SUBSCRIBER.

SUBSCRIBER acknowledges that V.S.I. cannot guarantee total accuracy nor certainty of discovery of names of decedent's being searched for in this program.

SUBSCRIBER's account will be charged the fee specified in the current V.S.I. price list, and SUBSCRIBER will be supplied with a death certificate for each justified "MATCH" (i.e., a substantial identity of a candidate's name and other information supplied by SUBSCRIBER, to a name and other information obtained from current California death records) UNLESS V.S.I. be notified in writing within 45 days of the death of the particular candidate listed by SUBSCRIBER with V.S.I. However, if the "MATCH" be proven false (generally, by the "SUBSCRIBER'S verified statement to said effect promptly delivered to V.S.I.) the specified fee will be credited back to SUBSCRIBER'S account with the exception of the cost of the death certificate supplied and the minimum service charge. Payment for a "STALE MATCH" (i.e., where notice be given by V.S.I. to SUBSCRIBER more than 120 days after the date of death) shall (on this program) be within the discretion of the SUBSCRIBER.

Billings will be prepared and mailed by V.S.I. to SUBSCRIBER at least semi-annually. Subscriber agrees to pay all moneys owed by SUBSCRIBER within twenty (20) days following the date such billings are mailed.

SUBSCRIBER (if not in default) may list additional candidates at any time for the charge specified on the current price list, and shall not be obligated to pay an original subscription fee in connection therewith. A listed candidate may be withdrawn by Subscriber at any time without charge.

Each of the parties hereto agrees to promptly notify one another of any change in their respective addresses or other pertinent information changes.

V.S.I. agrees to maintain SUBSCRIBER'S Candidate list as confidential information.

SUBSCRIBER agrees to appropriately compute and attach SUBSCRIBER'S check and to deliver it to V.S.I. with this document together with SUBSCRIBER'S Candidate Listing Sheets, all as described herein and in related instructions. Upon verification, V.S.I. shall deliver to SUBSCRIBER its acknowledgement, and shall promptly thereafter cause SUBSCRIBER'S candidates to be duly added to its list of candidates being regularly searched and compared to current comprehensive death records of the State of California. The date of said "acknowledgement" shall constitute the "Effective Date" of this agreement.

**INSTRUCTIONS FOR COMPLETING
CANDIDATE LISTING SHEETS**

Each page of the Candidate Listing Sheets contains 6 frames. One full frame is to be allocated to each candidate listed. Please type in the information called for in each of the areas enclosed in the "boxes". If you do not have all the information requested, type in what you have even if it is only the Candidate's name. The Listing Sheets are designed to be completed in a standard 10-pitch typewriter. If the Sheets are carefully inserted and the type lined up within the character segments at the outset, the typist may not have to make further adjustments to keep key strokes within the character segments. We have found considerable variations among typewriters, however, and it will not matter if the characters are not typed exactly within the segments. Candidates need not be listed in alphabetical order.

The Subscriber should fill in the box marked **Subscriber I.D.** on each sheet using a 6 to 10 character word selected by the Subscriber. The same Identification Word should be used on each page. It could be the firm name, an abbreviation thereof, or it could be wholly contrived (to maintain confidentiality). Numbers may be intermixed, or used to make up the entire group of identifying characters.

Each **Page number** should also be set forth on each page. The **Date** (on which the Sheets are filled in) need only be filled in on the first page.

Within each separate candidate frame there are thirty (30) character spaces provided for the **Last Name** of the Candidate. This should be adequate in all cases. Only 13 character spaces are provided for the **First Name** and for the **Middle Name** of the candidate. You may use merely an initial if that is what your records reflect. If the candidate has no middle initial leave this thirteen-character-block blank. If either the first or middle name exceeds 13 characters, type the name as far as you can and simply omit the remaining characters. If a candidate has a nickname and enough space remains in the box for the first name to add a (/) and the nickname, do so. If you cannot do so, or a candidate is known by different names, type the different names in new candidate listings as if different candidates. Be certain in such cases to fill in all information that you have regarding the candidate in each of the frames used for his or her aliases. Be certain also to list all such names for the same candidate in consecutive frames, and to draw a line in ink with arrows pointing to the last names in each frame so used. You should also write the word "alias" along that line. (See sample Listing Sheet. Be careful not to obliterate information typed in the boxes). This procedure could be used for a number of names used by a candidate.

The next boxes in each of the respective frames ask for the candidate's **Mother's Maiden Name** (insert her last name only even though there may be empty character spaces left), the **candidate's Birthdate**, etc. As mentioned, if you do not have information for these boxes, just leave the boxes blank. It is helpful (and sometimes more economical to the Subscriber) if the Subscriber can supply this information. It permits a more definite identification of a candidate and elimination of erroneous identifications (**FALSE MATCHES**).

In listing the candidate's **Place of Birth**, type only the state in which the candidate was born, or the foreign country in which the candidate was born. **Abbreviate here when necessary.** (There are only 6 character spaces provided.)

Note that the **Social Security Number** box has a shaded chamber at the end. This chamber is for a letter found at the end of some social security numbers. (Those letters are not important to our identification process).

When amending or supplementing information on a candidate which you have listed on a prior date, please be certain to include all the data now known about the candidate (i.e., information which the "Boxes" ask for) in all boxes, and also be careful to place an "X" in the special box to indicate that this is a "Change" and not a new listing.

A sample "Candidate Listing Sheet", depicting various situations, is enclosed. The sample may be of further assistance in completing the Sheets. If your supply of Sheets runs out, you can use your own photocopies of the form or request additional Sheets from Vital Statistics, Inc.

When the information on all of the Subscriber's Candidates has been typed onto the Listing Sheets, the Sheets should be fastened together with Acco or other type fasteners and mailed, together with the **SUBSCRIPTION DOCUMENT** and a check (correctly computed...see separate instructions) to "VITAL STATISTICS, INC., 401 N. Brand Blvd., Suite 408, Glendale, California 91203." A confidential computer print out will be returned to the Subscriber for proofing within several weeks thereafter. The return of the proofs will also provide notice that the Subscriber's list of candidates are already "on line" and are being regularly searched for "matches" with comprehensive official lists of recent decedents.
