Subject: Clearing Mailing List

After consulting with the Chairman, we have decided to send out the attached form to clear our mailing list. When the forms are returned, we will prepare an analysis of the information and suggest an appropriate distribution policy for Commission consideration. By the time of the February meeting, we should have sent out our reports (except for the eminent domain tentative recommendations).

We plan to send out the eminent domain tentative recommendations as a separate mailing. We will send this separate mailing only to persons who return the form and indicate that they want eminent domain material.

This memorandum is merely a progress report. We suggest that discussion of the distribution policy be deferred until we have prepared a ~~suggested distribution policy~~ for your consideration at a future meeting.
