Memorandum No. 4

Subject: Fish and Game Code

Since the December meeting Messrs. Stanton, Kleps, DeChambeau and I have engaged in three day-long sessions devoted to consideration of the Fish and Game Code, with particular reference to the comments of the Department of Fish and Game, the comments of the Legislative Counsel's office thereon, and Mr. Stanton's comments on both of these. (Those of Mr. Stanton's comments which you have not previously received are enclosed).

As a result of these discussions we are prepared to recommend a number of revisions of A.B. 616 for the consideration of the Commission. At the March meeting Mr. Kleps will make a formal presentation of A.B. 616 to the Commission and of the amendments thereof upon which we have agreed. The Commission will then have the opportunity to take its final action on revision of the Fish and Game Code and to formulate its recommendation to the Legislature respecting A.B. 616.

Please bring with you to the March meeting your copy of (1) A.B. 616, (2) the draft revision of the Fish and Game Code, (3) the present Code (4) the regulations and (5) your bradded folder of material relating to the Fish and Game Code, including therein the items attached.

Analysis of the Revised Fish and Game Code
Assembly Bill No. 616, 1957 Regular Session

This analysis of the revised Fish and Game Code shows the changes from the present law which would be effected thereby.

The revised code is based on the 1933 Fish and Game Code (Stats. 1933, Ch. 73, as amended). The revision was done by the California Law Revision Commission, pursuant to a 1955 concurrent resolution introduced by Mrs. Pauline Davis which requested such a revision (Stats. 1955, Res. Ch. 204). The drafting was done by the Office of Legislative Counsel, pursuant to a contract with the Law Revision Commission under which all policy decisions were referred to the Commission for its action thereon.

In preparing this analysis we compared the provisions of the bill as introduced with the text of the present law.* Throughout the revised code the language of the present law is rearranged, frequently with no change in legal effect. Such instances are noted in the analysis by the expression "no substantive change," or where the section is identical by "no change."

In certain instances in the bill a provision is inserted which is implied, but not expressed, in the present law. In such instances we have indicated that we think the bill does not add a new provision but simply rounds out the expression of the present law.

The analysis proceeds section by section as the provisions appear in the bill. The first number given is the number of the section in the bill. Following that,

and enclosed in parentheses, is an indication of the source of the provision in the present Fish and Game Code.

Several general matters concerning the revision should be noted:

(1) As a matter of arrangement, commercial fishing provisions relating to licensing and taking have been separated out and are treated together, commencing at Section 7600 and following, of the revised code.

(2) The general regulatory powers of the Commission with respect to the taking of fish and game - other than for commercial purposes - are set forth at Sections 200-250 of the revised code. Specific provisions are included to cover such problems as adequate availability of Commission regulations (Sec. 216), the superseding effect of Commission regulations (Sec. 219), and the continuance of Commission regulations as law if the general regulatory powers are terminated (Sec. 250).

(3) Insofar as the division of responsibility between the Fish and Game Commission and the Department of Fish and Game is concerned, no notation of substantive change is made in the event that the revised code merely reflects the existing law set forth in Sections 13, 13.1, 13.2 and 13.3 of the Fish and Game Code. A specific mention of substantive change is contained, however, where a shift from "commission" to "department" is made which appears to modify existing law.

(4) All penalty provisions have been arranged together at Section 12000 and following of the revised code.

(5) Many sections of the present Fish and Game Code, which apparently set seasons and limits for sport fishing, have been repealed because they have been superseded by Commission regulations.

(6) The general term "fish and game" has been replaced by "birds, mammals, fish and amphibia" throughout to reflect the Legislature's
