Dear Professor McDonough:

It is with a great deal of sorrow that we inform you of the passing on March 2nd, 1957 of our loved and respected partner Stanley S. Burrill. Mr. Burrill suffered a heart attack while in San Diego, where he had gone to try a lengthy and complicated case.

We have at hand your letter of March 6th, 1957 addressed to Mr. Burrill, and the accompanying contracts for the research study he was to undertake. We realize that your arrangements were for the employment of Mr. Burrill personally, and we are therefore returning the contracts and papers submitted with your letter. We regret that he will be unable to serve you because we know that he would have rendered, as he always did, a thorough and competent service.

We are sorry for the disruption that this may cause to your careful planning and scheduling. If we can in any way serve to lighten your burden, we will be most happy to do anything we can. We are in a position to carry the study forward, if it would be of help to you. The study outline which was previously forwarded to you was drafted by three attorneys in our Condemnation Department for Mr. Burrill's approval. These men are Mr. Robert Nibley, Mr. Albert J. Day and Mr. John McLaurin, all of whom specialize in condemnation law and have had many years experience. We are in a position to offer you their services if such are desired by the Commission. In such case it would be necessary for us to ask for
