Memorandum No. 2

Subject: Attendance at National Legislative Conference.

I believe that the attached letter is self-explanatory.

The National Legislative Conference will be held in Denver on October 7-9 of this year. Hotel reservations should be made before September 12. Attached is an extract from the preliminary outline program.

Our total amount budgeted for out-of-state travel is \$400, all of which is still available for expenditure. There is a possibility that if this amount is insufficient we can transfer some funds from "office" or "travel-in-state" to cover the actual expenses.

If the Commission decides to send its executive secretary to the conference the maximum amount of his expenses is estimated as follows:

Transportation:

First Class Air - round trip - tax exempt	\$137.50
Taxi - Airport to Denver, round trip	2.50
Mileage (round trip -- Palo Alto to S.F. Airport - 48 miles at .09¢)	4.32

Hotel:

October 6, 7, 8 and 9 4 days at \$12.50	50.00

Note: Range for single room is \$8.50 to \$20.00. Reservations would be requested for most inexpensive room.

Meals and Incidentals:

Estimated meals (three days)	\$ 20.00
Incidentals	<u>3.00</u>
Total	\$ 217.32

NOTE: Air schedules will be changed about September 18. This may make it possible to reduce expense. If tourist class air transportation can be used, cost will be \$97.70 instead of \$137.50.
