Subject: Meeting Dates

Possible dates for Commission meetings during 1969 are shown on the attached green sheet. If the suggested dates were adopted, the Commission would meet for 20 days, 5 evenings, and 1 morning during 1969. If the Commission wishes, an additional two-day meeting could be held on December 12-13, 1969.

The attached schedule supersedes the suggested schedule attached to Memorandum 69-12. We encountered some conflicts in clearing the original schedule through the San Francisco and Los Angeles offices of the State Bar. These conflicts required that we change the places of meetings, but the suggested dates have not been changed.

All of the meetings would be held in Los Angeles or San Francisco except for a meeting in San Diego in June. The Big Game (California v. Stanford) will be at Stanford during 1969. In light of the views expressed at the last meeting and the poor attendance at that meeting, the suggested schedule does not provide for holding the November meeting on Big Game weekend.

We have a firm reservation for the Board Room at the State Bar Building for all of the meetings in Los Angeles and San Francisco except that we have a tentative reservation for the Board Room in Los Angeles for the November meeting (we will use the Board Room in November unless our meeting conflicts with a meeting of the Board of Governors or the Disciplinary Committee).
