## First Supplement to Memorandum 70-76

Subject: Multi-Year Schedule of Projects

It is useful for the Commission from time to time to consider its various legislative assignments and to plan how and when those assignments will be completed.

Attached as Exhibit I (pink) is a multi-year schedule of projects. The Commission already has determined tentatively the content of the legislative program for 1971. You will recall that we have retained two consultants to submit a study on attachment and garnishment by October 1, 1970, and we plan (working with the State Bar Committee and others) to submit legislation to the 1971 Legislature to deal with the problems in this field of law that are most urgently in need of correction. We have distributed for comment a tentative recommendation on two aspects of pleading, and we plan to submit a recommendation on these topics to the 1971 Legislature. We also plan to submit a uniform relocation assistance statute to the 1971 Legislature and have distributed a tentative recommendation on that subject for comment. (We will consider the comments on the relocation assistance recommendation at the September meeting; the comments on the pleading recommendation will be considered at the October meeting.) We expect to receive the background study on the right of nonresident aliens to inherit by October 1, 1970. If this proves to be a simple topic (merely repeal of existing statutes or substitution of one or two sections for existing statutes), we could make a recommendation on the topic to the 1971 Legislature. Also, the Commission will need to determine whether any recommendations are to be made to the 1971 or subsequent sessions on the

sovereign immunity provisions recommended to the 1970 Legislature but not enacted (nuisance; plan or design immunity; liability for ultrahazardous activities).

The remaining portion of the multi-year program is tentative. To a considerable extent, we depend upon the receipt of a background study before we can consider particular topics.
