Subject: Priorities and Scheduling of Topics

The Chairman suggested that this would be a good time to have a report on the status of the various topics on which we have research contracts.

This report is attached as Exhibit I.

The Chairman also suggested that it would be convenient to have a list of the topics on our agenda. This list is attached as Exhibit II.

It may be helpful to the Commission to have the staff's suggestions for the priorities and scheduling of our work during the next few years. A suggested schedule is set out below. In connection with this schedule, it must be kept in mind that material for a particular session must be sent to the printer by October 1 before the session.

Based on past experience, the above schedule is an optimistic view of what the Commission can accomplish in the next five years. In fact, the consensus of the staff is that it would be unlikely that the schedule could be met. The schedule is designed to substantially complete work on two major studies during the five-year period: condemnation law and procedure and attachment, garnishment, and execution. The other topics included on the agenda are either "easy"

a priority. I suggest you play around with the schedule, inserting those topics you wish to give priority, and deleting those that you feel should not be taken up during the five-year period.

EXHIBIT I

STATUS OF OUTSTANDING RESEARCH CONTRACTS

Attachment, Garnishment, Execution

Professors Warren and Riesenfeld are consultants on this topic. We expect to receive an outline of the remaining work to be done on the topic and to discuss the outline and schedule the work at the April 1972 meeting.

Inverse Condemnation

Professor Van Alstyne is working on a background study on certain procedural aspects. Study is expected by September 1, 1972.

Condemnation Law and Procedure

Mr. Matteoni has prepared substantially all of the study on procedural aspects of condemnation and is now finishing up the remainder of the study.

Mr. Harvey is working on the study on apportionment of the award and related problems. Study is expected by September 1, 1972.

Oral Modification of Written Contract

Study is scheduled to be printed in May 1972 issue of Hastings Law Journal.

Right of Nonresident Aliens to Inherit

Rough draft of study delivered to Commission. Consultant is now preparing study for publication in California Law Review, and study should be ready for submission to law review by the end of May 1972.

Liquidated Damages

Study printed in last issue of California Law Review.

Disposition of Property Abandoned by Tenant

Professor Friedenthal is starting work on the study, the bill on this subject having failed to pass the 1971 Legislature. He expects to complete work on the study within a few months.

Arbitration

We do not expect to receive a study on this topic.
