#### Memorandum 72-58

Subject: Schedule for Consideration of Topics

At the September meeting, the Commission requested the staff to prepare a tentative schedule for consideration of topics at future meetings. Exhibit I (pink) attached is a comprehensive schedule for consideration of major topics at the next nine meetings. Exhibit II (yellow) is a schedule for consideration of the creditors' remedies topic and covers the period between now and July 1974. Exhibit III (green) is a schedule for consideration of the condemnation topic and covers the period between now and January 1975.

It is difficult to prepare even a tentative schedule because we lack background studies on some of the basic areas of condemnation and on jurisdictional attachment. Also, we are not confident as to when we will receive the study on the lessee's abandoned property. Nevertheless, we have prepared a tentative schedule (Exhibit I) that is based on the following goals:

(1) Recommendations will be submitted to the 1973 session on the following matters:

Claim and Delivery Statute (depends on reaction to our tentative recommendation which we are now distributing for comment)

Civil Arrest and Bail (recommendation being printed)

Wage Garnishment and Related Matters (recommendation submitted for approval for printing at October meeting)

(2) Recommendations will be submitted to the 1974 session on the following matters:

Prejudgment Attachment

Liquidated Damages

Lessee's Abandoned Property

- (3) Tentative Recommendation on Condemnation will be printed early in 1974.
- (4) Recommendations will be submitted to the 1975 session on the following matters:

Comprehensive Condemnation Statute

Execution

Any schedule must, of course, be very tentative because it is not possible to predict changes in priority that may occur as a result of judicial decisions and priorities set by legislative direction. Also, it is next to impossible to predict the amount of time it will take for the Commission to deal with the many exceedingly difficult areas of law that will be considered within the next year or so.

The staff believes that the attached schedules are ambitious but that the goals set in the schedules are possible to meet.
