Subject: Printing Schedule

We have maintained a record of the printing schedule for the last several months. Attached as Exhibit I is the record. You will note that we have received excellent service since the session recessed in September. Based on past experience, we expect that considerable delays will occur when the legislative session commences in January 1974, and we plan to call on our legislative members for assistance at that time.

It has become apparent that our printing program now in process involves about two or three times the amount of material we ordinarily print during a fiscal year. We encumbered during the past two fiscal years a considerable amount of money (\$15,000) to finish printing the eminent domain reports. Since we have eight reports now in the process of being printed (not including liquidated damages which should be approved for printing at the November meeting), we do not know even generally how much printing money we have spent during the past two months and how much we have available. Sometime ago, I worked out a procedure with the printing office whereby I would be advised monthly of the expenditures posted during the prior month and the balance available.

It is likely that we will not have sufficient funds to print the pamphlet on conforming changes in special district laws. Accordingly, I have not sent the copy for this pamphlet to the printer. Instead, I am planning to send the copy for the eight bills in this pamphlet to the Legislative Counsel to have them prepared for introduction at the 1974 session. When the bills have been introduced, we can then either print a report that refers to the bill number and sets out only the Comments to the sections but not the text of the sections, or perhaps we can prepare a paste-up that takes the text of the sections from the printed bill and the text of the Comments from copy we have set. In any case, we do not expect that the pamphlet will be available when the other eminent domain pamphlets are available.

Another problem created by the substantial volume of material to be printed has been the cost of checking and preparing the material for printing. The cost is primarily for temporary help to cite check the material prior to sending it to the printer. We have had to use research consultant moneys

to pay for an additional lawyer used temporarily for this purpose and also have had to use our temporary employee who was working on nonprofit corporations to assist in the cite checking. The result is that we have exhausted the money for research consultants. (We did finance the contract (approved at the last meeting) with the consultant on nonprofit corporations, and this contract has been approved by the State Personnel Board.)

No Commission action is needed or requested concerning the above matters. However, as a result of the financial situation, it is likely that our activities will be at a lower level in the future than in the past. (We expect that most of 1974 will be devoted to perfecting the eminent domain package.)
