Memorandum 80-27

Subject: 1980 Legislative Program

Attached (buff page) is a report on the 1980 Legislative Program. So that the Commission will be aware of the amendments made to the various bills, we outline them below.

1980 Cal. Stats. ch. 44 (AB 1676) - Quiet Title Actions

This bill was enacted after the amendments previously approved in substance by the Commission had been made.

AB 2115 - Agreements for Entry of Paternity and Support Judgments

This bill was substantially amended by the Assembly Judiciary Committee. The bill needs further consideration by the Commission. See First Supplement to Memorandum 80-27.

AB 2116 - Enforcement of Liens and Judgments After Death

This bill has not been amended.

AB 2117 - Married Women as Sole Traders

This bill was amended to add a savings clause. A copy of the bill is attached.

AB 2118 - Guardianship-Conservatorship

This bill has been substantially amended to make various technical corrections required to deal with problems created by legislation enacted after the 1979 comprehensive guardianship-conservatorship statute. We do not have a copy of the bill in its latest amended form since the amendments will be made on April 7.

AB 2119 - Veterans Guardianship Act

This bill was amended to add the savings clause previously approved in substance by the Commission.

AB 2120 - Special Assessment Liens When Property Acquired for Public Use

This bill has not been amended.

AB 2121 - Valuation Evidence

This bill has been amended to make the changes previously approved in substance by the Commission. The bill needs further consideration by the Commission. See Second Supplement to Memorandum 80-27.

AB 2146 - Enforcement of Claims and Judgments Against Public Entities

Several technical amendments were made to this bill. The significant amendment made to the bill revises proposed Section 906 (pages 5-6 of enclosed bill) relating to payment of interest on allowed claims. The significant provision is paragraph (1) of subdivision (b). This amendment was adopted by the Assembly Ways and Means Committee to satisfy objections from the Department of Finance and the State Board of Control. If the State Board of Control finds further technical amendments are needed, the staff plans to work out the necessary amendments.

AB 2184 - Probate Homestead

A correction has been made in the digest of the bill prepared by the Legislative Counsel; the bill itself has not been changed.

ACR 101 - Continues Authority to Study Existing Topics

No amendments to this resolution.

ACR 107 - Authorizes Study of Four New Topics

SB 1538 - Security for Costs

No amendments to this bill.

SB 1539 - Assignments for Benefit of Creditors

No amendments to this bill.

SB 1540 - Vacation of Public Streets and Service Easements

No amendments to this bill.

SB 1541 - State Tax Liens

A number of technical amendments are being made to this bill. We do not yet have copies of the amended bill.

SB 1542 - Interest Rate on Judgments
