## Memorandum 80-54

Subject: Study D-300 - Approval of Enforcement of Judgments Study

The staff plans to complete for the September meeting the entire recommendation relating to enforcement of judgments. We hope to accomplish this so that the entire recommendation can be approved for printing at the meeting, subject to revisions at the October meeting if necessary in view of the comments of State Bar Committees. We do not expect to make changes that do not involve policy issue decisions after the September meeting. The September meeting is the time to make technical and other changes that are a matter of taste. In addition, the Commissioners should raise any matters that they want to discuss at the September meeting so that the recommendation can be revised before it is prepared for printing. Accordingly, you will want to examine the material we send you with care for this is your last opportunity.

By the time of the September meeting, we will have lost both of our experienced Mag Card operators and our Administrative Assistant. We are sure that it will take some time for their replacements (after an unavoidable delay in their starting to work) to become fully productive. The impact of the loss of experienced personnel on our printing program will be a serious loss, and we need to begin coding copy for the printer as soon as possible.

We do not plan to delay sending you material to review until we have prepared the entire recommendation. There is a large amount of material, so we will be sending each portion to you as we finish it. Parts of the recommendation have not yet been approved by the Commission; other parts have already been approved, but will be sent to you for your review and so you will have a complete draft. Each part will be accompanied by a memorandum discussing significant staff revisions and policy questions yet to be resolved. Because we are sending this out piecemeal, there will be incomplete cross-references and cross-references to material you do not yet have.

Attached hereto is an outline of the statute portion of the recommendation. You will also receive a textual discussion of each part, comments to the repealed law, and conforming revisions in other statutes.
