Code of Civil Procedure §§ 680.010-724.260 (added). Enforcement of judgments

SEC. \_\_\_\_\_. Title 9 (commencing with Section 680.010) is added to Part 2 of the Code of Civil Procedure, to read:

TITLE 9. ENFORCEMENT OF JUDGMENTS

DIVISION 1. DEFINITIONS AND GENERAL PROVISIONS

CHAPTER 1. SHORT TITLE AND DEFINITIONS

§ 680.010. Short title

680.010. This title shall be known and may be cited as the Enforcement of Judgments Law.

Comment. Section 680.010 is new and provides a convenient means of referring to this title.

§ 680.110. Application of definitions

680.110. Unless the provision or context otherwise requires, the definitions in this chapter govern the construction of this title.

Comment. Section 680.110 is a standard provision found in the definitional portion of several California codes and laws. E.g., Code Civ. Proc. §§ 481.010, 1235.110; Evid. Code § 100; Veh. Code § 100.

§ 680.120. Account debtor

680.120. "Account debtor" means "account debtor" as defined in Section 9105 of the Commercial Code.

Comment. Section 680.120 is new.

680.130. "Account receivable" means "account" as defined in Section 9106 of the Commercial Code.

Comment. Section 680.130 incorporates the Commercial Code definition of "account." The term "account receivable" is used in this title because it is more descriptive than "account" and because it avoids confusion with the term "deposit account." See Section 680.210 ("deposit account" defined).

680.150. "Bona fide purchaser" means "bona fide purchaser" as defined in Section 8302 of the Commercial Code.

680.160. "Buyer in ordinary course of business" means "buyer in ordinary course of business" as defined in Section 1201 of the Commercial Code.

§ 680.190. Costs

680.190. "Costs" means costs and disbursements, including but not limited to statutory fees, charges, commissions, and expenses.

Comment. Section 680.190 defines costs to include all costs of collection. The section is not intended to expand or limit the amounts or items that are recoverable as costs. As used in this title, the term may in some cases be limited, such as in Section 702.620 (costs of levying officer).

§ 680.200. Court

680.200. "Court" means the court where the judgment sought to be enforced was entered.

Comment. Section 680.200, which defines "court" to mean the court where the judgment was entered, may in some cases be inapplicable. See, e.g., Sections 688.020 (enforcement of state tax liability), 704.750 (court in county where dwelling is located), 708.160 (court of similar jurisdiction in another county). See also Section 680.110 (application of definitions).

§ 680.210. Deposit account

680.210. "Deposit account" means "deposit account" as defined in Section 9105 of the Commercial Code.

Comment. Section 680.210 is new.

680.220. "Document of title" means "document" as defined in Section 9105 of the Commercial Code. A document of title is negotiable if it is negotiable within the meaning of Section 7104 of the Commercial Code.

680.240. "Equipment" means goods that are used or bought for use primarily in business (including farming or a profession) or by a judgment debtor who is a nonprofit corporation if the goods are not included in the definitions of inventory or farm products.

Comment. Section 680.240 is new. It is based on Commercial Code Section 9109(2) but refers to the judgment debtor (see Section 680.350)

rather than the debtor and omits the reference in Commercial Code Section 9109(2) to a governmental subdivision or agency.

#### § 680.250. Farm products

680.250. "Farm products" means goods that are crops or livestock or supplies used or produced in farming operations, or products of crops or livestock in their unmanufactured states (such as ginned cotton, wool-clip, maple syrup, milk, and eggs), while in the possession of a judgment debtor engaged in raising, fattening, grazing, or other farming operations. If goods are farm products, they are neither equipment nor inventory.

Comment. Section 680.250 is a new provision; it is based on Commercial Code Section 9109(3) but refers to the judgment debtor (see Section 680.350) rather than the debtor.

680.300. "Holder in due course" means "holder in due course" as defined in Section 3302 of the Commercial Code.

Comment. Section 680.300 is new.

680.330. "Judgment" means a judgment, order, or decree entered in a court of this state.

Comment. Section 680.330 is new. It continues the effect of former Section 1007 (order enforceable as judgment). A judgment enforceable under this chapter must be entered in this state. See the Comment to Section 681.010. A judgment is not effectual for any purpose until entered. See Section 664. See also Section 683.010 (enforceable upon entry).

§ 680.340. Judgment creditor

680.340. "Judgment creditor" means the person in whose favor a judgment is rendered or such person's assignee or successor in interest.

Comment. "Judgment creditor," as defined by Section 680.340, includes the person in whose favor the following types of judgments are rendered: money judgments, judgments for the possession of personal property, judgments for the possession of real property, and judgments for the sale of real or personal property.

680.400. "Negotiable instrument" means "negotiable instrument" as defined in Section 3104 of the Commercial Code.

680.420. "Personal property" includes both tangible and intangible personal property.

See, e.g., Sections 701.540 (notice of sale of real property) and 704.740 (homestead exemption).
