Memorandum 80-78

Subject: 1980 Legislative Program

Attached is a report on the 1980 Legislative Program. Fourteen of 15 bills recommended by the Commission were enacted (assuming the Governor signs the bill relating to vacation of streets). The one bill not enacted was the bill relating to the interest rate on judgments. We attached a copy of the bill on this subject, not recommended by the Commission, which has gone to the Governor. We ask you to review this bill. We recommend that its substance be included in the new comprehensive enforcement of judgments statute we are drafting. To conform to the interest rate change, conforming changes should be made in the provisions relating to sister state judgment; the bill that went to the Governor did not make these conforming changes in the sister state judgment provisions. The conforming changes were contained in the Commission bill that was not enacted.

SB 1542 - Interest Rate on Judgments. The Committee reported favorably another bill which provides a 10-percent interest rate (as recommended by the Commission) but continues the existing 7percent interest rate while a case is on appeal.
