## Memorandum 81-69

Subject: Research Contract

The 1981 legislative session authorized the Law Revision to study (on a priority basis) the statutes of limitation applicable to felonies.

Although the statute directing the study of this new topic will not be effective until January 1, 1982, we believe that an expert consultant should be retained as soon as possible to prepare a background study on this topic. The contract with the consultant would become effective on January 1, 1982. It takes some time to process the contract and we need to obtain a commitment of the consultant's time during 1982 by making the contract now.

The staff recommends that John B. Mitchell, now serving as a visiting professor at the University of Puget Sound Law School, be retained as the consultant. In response to our request for suggestions as to a person who might serve as a consultant, Professor Kaplan of Stanford recommended Mitchell. The office of the Attorney General recommended several assistant district attorneys as possible consultants, but the Office of Attorney General also indicated that they had checked with a source in the State of Washington and received an outstanding recommendation concerning Mr. Mitchell. Mitchell has practical experience; he represented over 600 criminal defendants during the past nine years. He is the author of a very readable article published in the January 1980 issue of the Stanford Law Review. Mitchell, The Ethics of the Criminal Defense Attorney—New Answers to Old Questions, 32 Stanf. L. Rev. 293 (1980). See the attached resume for additional background information.

The staff recommends that the Commission approve, and direct the Executive Secretary to make, a contract with Professor John B. Mitchell according to the following terms:

- (1) Compensation for the background study concerning the statute of limitations on felonies in California--\$4,000.
- (2) Additional amount for travel in attending Commission meetings and legislative hearings (at Commission request)—maximum \$1,000.
- (3) Contract to become effective on January 1, 1982, and background study to be completed and delivered to the Commission not later than January 1, 1983.

- (4) Contract to terminate on June 30, 1984.
- (5) Contract to follow terms of standard form of contracts with consultants who prepare background studies.

Professor Mitchell has indicated that he is willing to undertake to prepare this background study, primarily because of his continuing interest in this field. He is strongly recommended and the staff believes that we are fortunate to secure his services. We would like to make the contract as soon as possible so that we can respond satisfactorily to legislative inquiries concerning our progress on the topic.
