Subject: Schedule for Future Meetings

We are attempting to arrange for Dean Stein of the University of Minnesota Law School to attend our March meeting when we will be considering the manner of fixing attorneys' fees in probate proceedings. Dean Stein is the national expert on this subject. We may have to change the dates of the March meeting in order to permit him to attend.
