Subject: Probate Code Study Schedule

Exhibit 1 attached is a revised schedule on the Probate Code study. The staff was unable to complete work on one portion of the material previously scheduled for the January meeting. This is the material on sales. The schedule has been revised to reflect this and also to reflect the time anticipated to prepare material on other portions of the study. The schedule is consistent with the suggested meeting schedule proposed in Memorandum 85-22.

Exhibit 2 sets out the staff assignments for various portions of the Probate Code revision project and the State Bar Section Consultants on each portion.

Exhibit 3 is a tentative outline of the portion of the new Probate Code that will replace existing Division 3 (administration of estates of decedents). This outline should prove useful to those who are working with us on this project.

The staff has obtained funds to permit the renting this fiscal year of the modern word processing equipment we need and the purchase of the equipment after July 1, 1985 (if our proposed budget is approved by the Legislature). We have not been successful in obtaining an experienced probate lawyer to assist the staff on a full-time basis for six months. It is apparent that we need to obtain private funds to assist such a lawyer financially during the time he is working in our office. The Chairperson has been seeking to obtain the attorney and the funds. Perhaps at the January meeting, he can make a report on his success or lack of success.
