Legislative Program: Final Report on 1993 Legislative Program

Attached to this memorandum is a chart showing the final disposition of the Commission's 1993 legislation. All measures were enacted.

In addition to the Commission's regular legislative program, we were also able to use SB 1068 (Wright) as a vehicle for working out chaptering out and double-jointing problems on the Family Code at the end of the session. That bill is enacted as Chapter 876 of the Statutes of 1993.

Finally, the Commission is aware that the Legislature adopted SCR 26 (Lockyer) as Resolution Chapter 96 of the Statutes of 1993, referring to the Commission the study of SCA 3 pertaining to the unification of the trial courts.
