## 1994 Legislative Program: Final Report

Attached to this memorandum is a chart showing final action on bills in the Commission's 1994 legislative program.

Senate Bill 1868 (Campbell) on the effect of joint tenancy title on marital property was not set for hearing because Senator Campbell asked the Commission to see whether a compromise approach could be developed with the opposition. We were unable to achieve a consensus, and at the September meeting the Commission concluded it could not do better than its existing published recommendation on the matter. The State Bar plans to pursue the Commission's existing recommendation in the 1995 session. The staff is happy to have the State Bar take the lead on this matter. We are prepared to provide explanatory material to legislators and to appear before legislative committees to explain the Commission's proposal in connection with the State Bar effort.
