Re: Procedure at March Meeting

Because the materials for Agenda Item #5 (Statutes Made Obsolete by Trial Court Restructuring) at the March meeting of the Commission are so voluminous, and because time to complete consideration of them is limited, the Commission's Chairperson Joyce Cook has authorized the following procedure for this matter.

I believe the last county clerk in the state who still held the title and function of the clerk of the court was in Trinity County, and the court in that county appointed their executive officer as clerk of the court under 69898 G.C. several years ago. In response to the request for comment, I would therefore reply that there no longer appear to be any county clerks who continue to act as court clerk in any county, and that it does not appear necessary to preserve statutes authorizing that or providing reimbursement to counties for doing so. I would, however, preserve the language of subdivision (b) clarifying the provisions applicable to deputy court clerks by moving it to 71620. – L. Jackson

To clarify the authority of the executive officer and of the clerk of the superior court, and to establish explicitly that appointees to these offices have the standing of public officers within the meaning of the Government Code, with all the prerequisites, responsibilities and appointment procedures appurtenant thereto, it would be helpful to add a sentence in subdivision (b) to the effect that the executive or administrative officer and the clerk of the trial court are public officers within the meaning of Chapter 1 (commencing with Section 1000) of Division 4 of Title 1. – L.
