Memorandum 2007-39

Legislative Program: Status of Bills

This memorandum outlines the final status of the Commission's 2007 legislative program. See the attached table.

Overall, the legislative program was successful. One bill was held over as a two-year bill, which could still be enacted next year. All of the others were enacted this year.

Matters relating to the legislative program are discussed briefly below.

AB 250 (DEVORE) — REVOCABLE TOD DEED

We received a copy of a letter from Mary Pat Toups to the members and staff of the Senate Committee on the Judiciary, regarding AB 250 (DeVore). The letter included a copy of a recent article on the transfer on death deed concept. See Gary, *Transfer-On-Death Deeds: the Nonprobate Revolution Continues*, 41 Real Prop. Prob. & Tr. J. 529 (2006). The letter also included an abridged version of the article that was printed in a practice periodical. See Gary, *Transfer-On-Death Deeds*, GP Solo, Sept. 2007, at 22.

AB 310 (SILVA) — TECHNICAL AND MINOR SUBSTANTIVE CORRECTIONS

AB 310 would make a variety of technical and minor substantive improvements to the law. See *Technical and Minor Substantive Statutory Corrections*, 35 Cal. L. Revision Comm'n Reports 219 (2006).

Technical amendments to the bill were made on the request of the Senate Committee on the Judiciary. The Commission Comments to two sections of the proposed law need to be revised to conform to the amendments.

The staff recommends that the Commission ratify the following revised Comments:

Code Civ. Proc. § 12a (amended). Calculation of time

Comment. Subdivision (b) of Section 12a is amended to correct the cross-reference to former Section 946, which was repealed by 1968 Cal. Stat. ch. 385, § 1. The relevant substance of former Section 946 is continued in Section 921.

Subdivision (b) is further amended to delete the cross-references to former Sections 974 to 982. Those provisions have been repealed. See 1963 Cal. Stat. ch. 871, § 15. Justice and police courts no longer exist, so there are no corresponding new provisions.

Section 12a is also amended to make grammatical corrections and delete surplus language.

Code Civ. Proc. § 904 (amended). Appeal in a civil action or proceeding

Comment. Section 904 is amended to delete an obsolete cross-reference. Former Section 904.4, relating to an appeal from a justice court, was repealed by 1976 Cal. Stat. ch. 1288, § 14.

On ratification, those revisions will be memorialized in an appendix to the 2007-2008 Annual Report.

AB 403 (Tran) — CLRC STUDY OF ATTORNEY-CLIENT PRIVILEGE AFTER CLIENT'S DEATH

As originally introduced, AB 403 would have revised the law to allow an attorney to claim the attorney-client privilege, even if the holder of the privilege is no longer "in existence."

The bill was amended in the Senate to delete that change and instead require a Commission study of the issue:

The California Law Revision Commission shall study the issue of whether and, if so, under what circumstances, the attorney-client privilege should survive the death of the client. The commission shall report all of its findings to the Legislature on or before July 1, 2009.

See AB 403, § 2 (as amended July 18, 2007).

The bill has been enacted. See 2007 Cal. Stat. ch. 388. The scheduling of this new study will be discussed in the "New Topics and Priorities" memorandum at the December 2007 meeting.

ASSEMBLY BILL 1610 (NÚÑEZ & ENG) — PETROLEUM REFINERIES

Assembly Bill 1610 (Núñez & Eng) addresses the maintenance of petroleum refineries. Among other things, the bill would have required the Commission to conduct a study of the laws governing petroleum refineries.

The bill failed passage on the Senate floor on September 12, 2007.
