## Memorandum 2011-27

---

**Meeting Schedule**

---

For the last several years, the Commission has followed a pattern of meeting approximately every other month for one day. That has worked reasonably well for our present staffing level. It allows us to produce a sufficient amount of material for the meeting, and permits reasonable progress on most topics. The schedule proposed for 2012 would follow that general schedule.

Consistent with our past practice, proposed Sacramento meetings are scheduled for Thursdays. That should make it easier for the legislative members of the Commission to attend. Other meetings are generally scheduled for Fridays, on the assumption that a Friday meeting would be more convenient for non-legislative Commissioners.

In 2011, all but one of the meetings was scheduled to be held in Sacramento. This was done to save travel costs, as the staff does not need to fly when meeting in Sacramento, and many of the Commissioners voluntarily waive reimbursement of their travel expenses when travelling north. Those savings have been important, as budget constraints worsen each year.

That said, the staff recognizes that this practice imposes a disproportionate burden on our southern California Commissioners, and makes it harder for members of the public in that region to attend Commission meetings. The schedule proposed in this memorandum was prepared assuming that we would continue the tilt toward Sacramento meetings, but Commissioners should feel free to change that practice if it is no longer desirable.

Taking into account the Legislature's calendar, known scheduling conflicts, airline schedules, holidays, staff vacations, weather, etc., the staff proposes the following meeting schedule for 2012:
