## Memorandum 2020-41

## **Election of Officers**

Each year, the Commission<sup>1</sup> elects a Chairperson and Vice Chairperson to serve a one-year term, ending on August 31 or until the election of successors, whichever is later. Thus, the terms of the incumbent Chairperson, Victor King, and the incumbent Vice Chairperson, Crystal Miller-O'Brien, will end on August 31, 2020.

Regarding the Commission's officers, the Handbook of Practices and Procedures states:

## 150. Officers

- (a) The officers of the Commission are the Chairperson<sup>2</sup> and the Vice Chairperson.
- (b) The terms of office are one year, commencing on September 1.3 Officers hold office until the following September 1 or the election of successors, whichever is later.4
- (c) In case of a vacancy in the office of Chairperson or Vice Chairperson, the Commission shall elect new officers for the remainder of the term.<sup>5</sup>
- (d) No officer is eligible to succeed himself or herself in the same office in which the officer has served a full term.<sup>6</sup> However, an officer who has served for less than a full term may succeed himself or herself in the same office for a full term.<sup>7</sup> If the Chairperson is reelected to office under this provision, the incumbent Vice Chairperson is eligible for reelection even though

reelection may result in the Vice Chairperson succeeding himself or herself for another full term.<sup>8</sup>

(e) Before the terms of the Chairperson and Vice Chairperson end, the staff will prepare a memorandum entitled "Election of Officers" for the Commission to consider at an upcoming meeting. This will provide an opportunity for the Commission to elect officers for the coming term.

With that information in mind, the Commission should elect a new Chairperson and Vice Chairperson to take office on September 1, 2020, and hold office until August 31, 2021, or the election of successors, whichever is later.
