2021 Legislative Program (Status Report)

The attached table shows the status of Commission-related legislation in 2021.¹ As shown, all of the proposed bills have been approved by the Legislature and have either been signed by the Governor or await the Governor's signature. The concurrent resolution that sets out the Commission's study authority (ACR 24 (Chau)) does not require the Governor's signature to take effect. It has already been chaptered.

Further information about Assembly Bill 473 (Chau) and Assembly Bill 474 (Chau), relating to the recodification of the California Public Records Act, is presented in a supplement to this memorandum.

As noted in a prior memorandum, ACR 95 (Cunningham & Wicks), would authorize the Commission to study specified aspects of anti-trust law. That resolution has been approved by the Assembly (without a single no vote, in committee or on the floor) and is now pending committee assignment in the Senate.
