Antitrust Law: Status Report

This memorandum provides an update on the status of the Commission's study of antitrust law. The new developments are as follows:

- At the May 18, 2023, meeting, Professor Ausra Deluard will make a presentation on Antitrust Mergers. A brief biography of Professor Deluard was attached in an Exhibit to Memorandum 2023-22.
- At the June 22, 2023, meeting, Professor of Law Alison Jones of King's College London, will make a presentation on European Union competition law. A brief biography of Professor Jones is attached as an Exhibit to this memorandum.
- The staff has begun outreach to schedule presentations for the second half of the year. Consistent with the Commission's expressed interests, the staff is attempting to arrange presentations on the recent antitrust legislation in the U.S. House and Senate and in the New York State Senate.

As always, the staff is profoundly grateful to the subject matter experts who have volunteered their time to the assist the Commission in this study.

Professor Alison Jones

Alison Jones is a Professor of Law at King's College London. Prior to joining King's, Alison read law at Girton College, Cambridge, worked at Slaughter & May and completed a BCL at Christ Church, Oxford. Alison's research is principally in the sphere of competition law. She is the co-author of a core text on EU Competition Law, 'Jones and Sufrin's EU Competition Law: Text, Cases, and Materials' (Oxford University Press) (8th edition currently in preparation) and has published a number of papers in refereed journals and chapters in edited collections. She is currently working on a project on combatting corruption and collusion in public procurement processes.
