- The staff is monitoring the State Budget in view of a Budget Letter alerting Executive Branch agencies of the current deficit in the State Budget.

# **New Topics**

The Commission considered Memorandum 2023-47 and its First and Second Supplements, presenting the material for the Commission's annual consideration of new topics suggestions and work priorities.

During the meeting, the Commission received further comments from two individuals whose written suggestions were attached to and discussed in the memorandum: Sarah Porter (regarding access to old investigatory records under the California Public Records Act) and Rajesh Sinha (regarding the calculation of child support obligations).

The Commission approved the work priorities for 2024 described on pages 15-16 of Memorandum 2023-47.

# **Annual Report**

The Commission considered Memorandum 2023-48, presenting a staff draft of the body of the Commission's 2023-24 Annual Report, an appendix containing a supplemental report relating to two prior Commission recommendations, and an appendix containing Commissioner biographies.

The Commission approved the report and appendices for publication and distribution to the Legislature and the Governor, after the staff makes technical changes, finalizes and adds all remaining appendices to the report, and adds the following Commissioner activity:

On November 8, 2023, Commissioner Jenkins participated as a guest speaker in a Loyola Law School class, "Government Lawyering: The Intersection of Law & Politics," to discuss the role of the Office of Legislative Counsel in the legislative process.

#### STUDY B-750 — ANTITRUST LAW

Dan Robbins, Immediate Past President of the Uniform Law Commission, and Prof. Daniel Crane, of University of Michigan School of Law, presented on the draft Uniform Antitrust Pre-Merger Notification Act. The Second Supplement to Memorandum 2023-49 provides the PowerPoint presentation used by Prof. Crane, who served as Reporter for the Uniform Act. The First Supplement to Memorandum 2023-49 includes a comment letter about the Uniform Act from certain stakeholder groups.

The Commission also considered Memorandum 2023-49, which provides a status update for this topic. The memorandum includes, as attachments, a copy of the draft Uniform Act, biographies for the presenters, and a comment letter related to European competition law. No Commission decisions were required or made.

The Commission received public comment from Mr. Lee Hepner, a representative of the group that provided the comment letter that was included in the First Supplement to Memorandum 2023-49.

# STUDY G-300 — STATE AND LOCAL AGENCY ACCESS TO CUSTOMER INFORMATION FROM COMMUNICATION SERVICE PROVIDERS

The Commission considered Memorandum 2023-50, presenting a status update for this study. No Commission decisions were required or made.

#### STUDY H-109 — LANDLORD-TENANT TERMINOLOGY

The Commission considered Memorandum 2023-51 and its First and Second Supplements, presenting a proposed study plan.

The Commission approved the presented study plan. The Commission also discussed and the staff will explore possibilities for securing an extern to assist with study-related research.
