**CLRC Staff Note.** This document lists all sections and Official Comments affected by 2001 Cal. Stat. chs. 44, 52, 59, 115, 141, 230, 417, 428, and 812 — nine bills sponsored by the California Law Revision Commission in the 2001 legislative session. This list correlates to the Comments, meaning that there is a Comment for each entry in this list and there should not be any Comments for sections that are not listed here.

Page cites preceded by “X” are preprint reports that will appear in the next Annual Report. The text of the Comments won’t change, but the page number will.
