CLRC Staff Note. This document, the second of two parts, lists sections and Official Comments affected by 2002 Cal. Stat. chs. 293, 389, and 784 and Cal. Stat. res. ch. 88 — three bills and one resolution sponsored by the California Law Revision Commission in the 2002 legislative session. This list correlates to the Comments, meaning that there is a Comment for each entry in this list and there should not be any Comments for sections that are not listed here.

Page cites preceded by "X" are preprint reports that will appear in the next Annual Report. The text of the Comments won't change, but the page number will.

- As to Chapter 293 (Eminent Domain), references are to the original comments in Evidence of Prejudgment Deposit Appraisal in Eminent Domain, 31 Cal. L. Revision Comm'n Reports 109 (2001) (referred to as "31:109").
- As to Chapter 389 (Admin. Rulemaking), references are to the original comments in *Administrative Rulemaking Refinements*, 31 Cal. L. Revision Comm'n Reports 259 (2001) (referred to as "31:259").
- As to Chapter 784 and Resolution Chapter 88 (Trial Ct. Restruct.), references are to the original comments in Statutes Made Obsolete by Trial Court Restructuring: Part 1, 32 Cal. L. Revision Comm'n Reports 1 (2002) (referred to as "32:1"), and to the superseding comments in the Report of the California Law Revision Commission on Chapter 784 of the Statutes of 2002 (Senate Bill 1316), 32 Cal. L. Revision Comm'n Reports X-1501 (2002) (Appendix 5 to the forthcoming 2002-2003 Annual Report, referred to as "32:AR APX 5"). A few of the revised comments are subject to final Commission approval. The applicable sections are noted with an asterisk.

Some sections in SB 1316 (Ch. 784) were chaptered out by or subordinated to other legislation. Many of the conflicting bills incorporated the SB 1316 amendments. The enacting bill is identified in the list, below. The Official Comments to these sections address *only* the portion of the conflicting bill's revision that incorporates the Commission-sponsored amendment.

The proposed constitutional amendments and corresponding Official Comments are contingent upon voter approval of Proposition 48 on the November 5, 2002 ballot.
