## **Approval of Actions Taken**

Unless otherwise indicated, the Committee decisions noted in these Minutes were approved by all members present at the meeting. If a member who was present at the meeting voted against a particular decision, abstained from voting, or was not present when the decision was made, that fact will be noted below.

#### **New Business**

The Committee considered Memorandum 2025-04, which discusses automatic disqualifications of a judge and related matters. The Committee heard from the invited presenters on that topic.

The Committee is grateful for the participation of all of the panelists.

After discussion, the Chair directed staff to continue developing a proposal that would address abuse of "blanket" disqualifications under Code of Civil Procedure § 170.6.

The Legal Director gave a presentation on the status of pending legislation implementing Penal Code Committee recommendations, an update on violent crime statistics for the first quarter of 2025 (see Memorandum 2025-06), and a preview of the California Prison Data Dashboards developed with the California Policy Lab.

## **Ongoing Business**

The Committee considered Memorandum 2023-07, which presented updates on research from the April 2025 meeting. The Committee gave staff the following direction:

- Retroactivity: Continue developing a recommendation for the retroactivity of the recent California Supreme Court case *People v. Collins*. Separately, reassess a recommendation on general retroactivity for new caselaw.
- Coercion defense: Monitor developments in AB 938 and contact experts on this issue to determine whether developing additional factors for this defense is appropriate.
- Vacatur motions based on IPV and related: Given the small nature of the proposed amendment to the Penal Code (adding additional examples to the "ameliorative statutes" in Penal Code § 1171(a)), staff will evaluate if there is continued interest in introducing that change in a bill for this session.
- Self-defense in intimate-partner violence cases: Clarify that this proposal would apply in other domestic abuse situations and not just intimate-partners.

The Committee also heard public comment.

## **Administrative Matters**

The Committee considered Memorandum 2025-05 presenting draft Minutes for the Committee's April 2025 meeting.

The Committee approved the Minutes without change.
