Bagley-Keene Open Meeting Act

The Commission considered Memorandum 2025-13, summarizing the Bagley-Keene Open Meeting Act. No Commission action was required or taken.

2024-2025 Annual Report

The Commission considered Memorandum 2025-14, presenting a staff draft of the body of the Commission's 2024-25 Annual Report, and an appendix containing Commissioner biographies.

The Commission approved the report and appendix for publication and distribution to the Legislature and the Governor, after the staff makes technical changes, and finalizes and adds all other required appendices to the report.

2025 LEGISLATIVE PROGRAM

The Commission considered Memorandum 2025-15, discussing the Commission's 2025 legislative program.

No Commission decisions were required or made.

STUDY B-750 — ANTITRUST LAW

The Commission considered the following memoranda:

- Memorandum 2025-21, presenting draft language options for Single Firm Conduct and Supplements 1 and 2 thereto
- First Supplement to Memorandum 2025-21
- Second Supplement to Memorandum 2025-21

The Commission deferred decisions on the draft staff recommendations until the June 26, 2025 meeting in order to solicit further public comment and directed staff to:

- Do no further work on Option 3
- Consider, factoring in public comments, developing an additional option between Options 1 and 2
- Propose mandatory, codified language based on the legislative findings and declarations

Additionally, Commissioners Carrillo and Simpson proposed several technical and clarifying amendments.

The Commission encouraged interested parties to submit public comments on the language related to the three options in Memorandum 2025-21 for consideration at its June 26, 2025 meeting.

STUDY E-200 — RECODIFICATION OF TOXIC SUBSTANCE STATUTES

The Commission considered Memorandum 2025-16, presenting a reorganized version of a cumulative draft of proposed recodified provisions of Chapter 6.5 of Division 20 of the Health and Safety Code that were provisionally approved by the Commission for inclusion in a future tentative recommendation.

The Commission provisionally approved the reorganization of the presented draft.

The Commission also considered Memorandum 2025-17, presenting a staff draft of additional proposed recodified provisions of Chapter 6.5 for provisional inclusion in the future tentative recommendation.

The Commission provisionally approved the inclusion of the proposed revisions presented by Memorandum 2025-17 in that future tentative recommendation.

STUDY G-300 — STATE AND LOCAL AGENCY ACCESS TO CUSTOMER INFORMATION FROM COMMUNICATION SERVICE PROVIDERS

The Commission considered Memorandum 2025-18, presenting a draft tentative

recommendation.

The Commission approved the release of the draft tentative recommendation for public comment with direction to staff to include in the recommendation reference to the provision that a government entity may petition the court to order the service provider to deliver the notice to the subscriber on behalf of the government entity if the government entity is not able to deliver notice to the subscriber.

STUDY I-100 — EQUAL RIGHTS AMENDMENT

The Commission considered Memorandum 2025-19, presenting a draft tentative recommendation.

The Commission approved the draft tentative recommendation with direction to staff to minimize the background information regarding the recent federal executive orders.

STUDY I-200 — TERMINOLOGY RELATING TO PERSONS WITH DISABILITIES

The Commission considered Memorandum 2025-20, providing a status report on the study. No Commission action was required or taken.
